

1. Bagmati Municipality, Office of Municipal Executive invites electronic bids from eligible bidders for the construction of *following works* under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

3. Bidder need to submit their bid electronically by downloading the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of *Rs 5000* for the bid in the Sanchit Kosh Account of Bagmati Municipality, Office of Municipal Executive, account no-45CA052639552401 at NIC Asia bank Ltd, Hariwon Branch till 8/01/2020.

4. Electronic bids having its contract name and identification number must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 noon on 9/01/2020. Bids received after this deadline will be rejected.

5. Bids shall be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours for S.No.1, at 14:00 for S.No.2, at 15:00 for S.No.3, at 16:00 for S.No.4 on 9/01/2020 at Bagmati Municipality, Office of The Municipal Executive, Karmaiya, Sarlahi. There will be no any obstruction to open bidding document if bidder representatives are not present.

6. Electronic Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security amounting mentioned on the above table, which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the bid security in the form of cash, the cash should be deposited in **Dharauti Account of Bagmati Municipality**, **Office of Municipal Executive**, **Account no- 45CA052639552404 at NIC Asia Bank Ltd. Hariwon, Sarlahi and** submit the Bank Voucher of the deposited amount of cash along with the bid.

7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
