2. Bagmati Municipality, Office of Municipal Executive invites electronic bids from eligible bidders for the construction of Construction of Bagmati Aaryaghat and Park facilities. under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 27 Crore  
Minimum Work experience of similar size and nature: One project of Aaryaghat or Park , value of which should not be less than 14.5 crore.

3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Bagmati Municipality, Office of Municipal Executive, Karmaiya, Sarlahi, Province Two, Nepal or may visit PPMO e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).
5. If hard-copy is allowed then a complete set of Bidding Documents may be purchased from the office Bagmati Municipality, Office of Municipal Executive, Karmaiya, Sarlahi, Province Two, Nepal by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of 10000.0 NRs. till 25-08-2022 10:00 during office hours.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below

Sealed or electronic bids must be submitted to the office Bagmati Municipality, Office of Municipal Executive, Karmaiya, Sarlahi, Province Two, Nepal by hand/courier or through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 25-09-2022 12:00. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 25-09-2022 13:00 hours at the office of Bagmati Municipality, Office of Municipal Executive Madhesh Province, Karmaiya Sarlahi Province Two Nepal. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 5513000 which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.

Participation as Prime contractor, management contractor, or subcontractor, in at least One (1) Contract of Aaryaghat or Park within the last five (5) years, with a value of at least NRs 14.5 crore that have been successfully or are substantially completed and that are similar to the proposed works. The similarity shall be based on the physical size, complexity, methods, technology or other characteristics as described in Section VI, Works Requirements.
